

# Privacy Policy

This privacy statement was last updated in February 2026.

In this privacy statement, we explain what we do with your data that we obtain through <https://atlas.isig.it>. We recommend that you read this statement carefully. In processing your data, we comply with applicable privacy legislation. This means, among other things, that:

- We clearly communicate the purposes for which we process personal data;
- We limit the collection of personal data to what is necessary for legitimate purposes;
- We request your explicit consent where required;
- We adopt appropriate security measures and require the same from data processors;
- We respect your right to access, rectify, or erase your data;
- Processing is carried out using electronic tools in compliance with the principles of lawfulness, fairness, transparency, and data minimization;
- Information is processed in a way that minimises the risk of indirect identification of data subjects.

## 1. Purposes of Processing and Categories of Data Processed

Personal data are collected and processed for the following purposes:

- To ensure the proper functioning of the platform;
- To enable registration to the platform;
- To allow users to use the features and tools provided (e.g., Self-Assessment, Strategy Builder, Contribution Tool);
- To improve user experience and provide personalized content when optional data are supplied.

The data collected during platform registration and use of its features are divided into:

- Mandatory data (necessary for registration and use of services):

- IP address
- Email address
- Username
- Optional data (voluntarily provided by the user to enrich their profile and improve the experience):
  - Role
  - Organization
  - Area of expertise
  - Country
  - Profile picture
  - Geolocation
  - Additional data resulting from voluntary use of the platform's tools

**Legal basis:** Consent for optional data; performance of the service for mandatory data.

**Retention period:** Until account termination + 6 months for registered data; 6 months for anonymous/statistical data.

## **2. Data Processors and Sharing with Third Parties**

Personal data may be processed by:

- Authorised internal staff of I.S.I.G.;
- IT service providers acting as data processors pursuant to Article 28 GDPR.

Data are not shared for marketing or advertising purposes. In the event of mergers or acquisitions, data may be shared with new operators in compliance with applicable law.

## **3. Cookies**

The website uses technical and functional cookies to ensure the proper functioning of the platform.

## **4. Disclosure Practices**

Personal data may be disclosed if required by law or by competent authorities, to the extent permitted by applicable regulations.

In the event of a sale, merger, or acquisition of the platform, data may be transferred to advisors or potential buyers, always in compliance with the law.

In all cases, personal data will be processed and stored within the European Union and will not be transferred to third countries outside the EU.

## **5. Security**

We are committed to safeguarding personal data. We take appropriate security measures to limit misuse and unauthorized access to personal data. This ensures that only necessary persons have access to your data, that access is protected, and that security measures are regularly reviewed.

## **6. Third-Party Websites**

This Privacy Policy applies exclusively to this platform.

It does not extend to:

- Third-party websites or services that may be accessible through links published on our platform;
- Third-party websites, applications, or platforms that contain a link to our platform.

We do not exercise any control over the data processing practices adopted by such parties and cannot guarantee that they operate in accordance with the same data protection and security standards.
